2. Please give me details of the transfer (incoming) of Assistant Professors at your institutions/college since 01 January 2019 in tabulated format (Sl. No., Name of the Teachers, Subject, Reservation Category, and Date of Joining, Name of the source college).
3. Please give me the number of sanctioned vacancies of assistant professors of different categories as of 31st March, 2021 of all the subjects in your institutions/college.
